NRW MAC vs Monterey County

This past year has been a struggle for all. Lake Nacimiento is a go-to haven for locals as well as visitors and more than ever we need our lake to be thriving. Although spring has arrived, the rain from this last winter wasn't adequate to bring the lake level back to where we need it to be. Now, to make matters worse — **Monterey County has started large releases of water again!**

We Need Proper Water Management RIGHT NOW!

The NRW MAC lawsuit moved ahead throughout 2020 and in recent months, and we held off several attempts by Monterey to crush our legal team's efforts. Monterey failed in its demurrer (a response in a court proceeding in which the defendant does not dispute the truth of the allegation but claims it is not sufficient grounds to justify legal action) in two causes of action: **1) breach of contract**, and **2) violating the state permit to operate the dam**. These are major points NRW MAC is emphasizing in its lawsuit against Monterey.

Monterey succeeded in forcing us to amend our complaint on some of our other causes of action. For example, the court sustained Monterey's objection to our cause of action for *inverse condemnation* (entitles property owners to just compensation if their property is damaged by a public use), on the grounds that: **1) NRW MAC "lacked standing,"** and **2) there was no "taking of property."**

These components are vital in our lawsuit, so in order to cure the "standing" deficiency, NRW MAC added three named plaintiffs to our second amended complaint to show their "loss" of property.

We filed our second amended complaint on March 29, 2021, in response to Monterey's demurrer, with the aim of preserving all five of our causes of action going forward. We are currently waiting for Monterey to either answer our complaint or demur to it again. If Monterey merely answers, then we advance to court with all causes of action preserved. If they demur, we will go back to court for another hearing on our respective arguments.

We have weathered the storm in court so far, we've made good headway in pursuing our case, and we're at the tipping point of success. We need your help to make this success a reality.

Monterey Begins Water Releases

We MUST stop Monterey’s continued water mismanagement at the lake, and we strongly believe that we will — with your help.

The latest proposed Monterey County Water Resource Agency (MCWRA) release schedule (above) shows how Lake Nacimiento will look without the proper water management that it needs. We’re in for another dry, dusty summer, and once again, Monterey is draining large volumes of water out of the lake without regard for recreational lake users, property owners, farmers, or wildlife.

California Water Rights

Let’s be clear about water rights. Water in California is protected for the use and benefit of all its citizens. **California's waters cannot be owned by individuals, groups, businesses, or governmental agencies.** Permits, licenses, and registrations give individuals and others the right to beneficially use reasonable amounts of water.

Monterey was first provided a grant in 1958, based on their application to develop a first-class recreation area at Lake Nacimiento, thereby making a long-term promise to promote and develop recreational facilities at Lake Nacimiento.

Monterey was again licensed in 1964, with this statement of purpose: “Recreational use at Lake Nacimiento Reservoir within San Luis Obispo County and irrigation, domestic, municipal, industrial and recreational uses within an area of Monterey County.”

In 1996, Monterey was once again granted a permit subject to prior rights that *authorized specific purposes* for using the water for irrigation, industrial, municipal, recreation, and domestic use.

There are **no percentages of water** listed in those grant rights. There is **no single group** that owns the water. In fact, there are five groups with interest rights that share the water in Lake Nacimiento and **ALL FIVE** are entitled to the water!



The Recreation Component

The predecessor to MCWRA, the Monterey County Flood Control and Water Conservation District (the “District”), built Lake Nacimiento in the mid-1950s, for recreation, flood control, and water conservation. To begin construction, the District first had to condemn and take private properties in and around the reservoir site by eminent domain. The District had eminent domain powers under the *Monterey County Flood Control and Water Conservation District Act*. At that time, the San Luis Obispo County Board of Supervisors approved the eminent domain by Monterey because they were paying to have the dam built on San Luis Obispo county property.

In part, this Act gave the District the power to condemn “lands deemed by the supervisors of the district to be **necessary or convenient for the installation, construction, use and maintenance of recreational areas or facilities including picnic grounds, play grounds, camp grounds, home sites, boats and fishing, bathing or other facilities for use by the public...**” Therefore, the provision of recreation at the reservoir was **key** to allowing the construction to commence. *(Boldface supplied by NRWMAC for emphasis.)*

To put it simply, Monterey claimed and based recreational support at Lake Nacimiento as an *equal right* to take land. They must continue to support recreation or they can face invalidating their right to that land.
