#### **Monterey Reservoir Operations Meeting: Thursday morning, October 26, 2023, at 10:30 a.m.**

This meeting will be held at Heritage Ranch in the Community Services District (CSD) meeting room, 4870 Heritage Road, Paso Robles, California 93446. Following the meeting, the committee members will take a short lunch break, and then there will be a scheduled dam inspection tour. The Monterey Reservoir Operations committee (ResOps) has indicated that they will allow a few lake residents to join the tour. The meeting is open to the public.

NRWMAC believes it would be beneficial for all interested parties to be in attendance to observe a ResOps meeting and to also show Monterey County the overwhelming support there is for Lake Nacimiento directly from its communities' residents and fans in a friendly face-to-face meeting. As always, we encourage politeness and respect for the official decorum of government meetings such as this one.

#### **NRWMAC Lawsuit Hearing: November 17, 2023, at 1:30 p.m.**

The last court hearing in September was a big win for NRWMAC and Lake Nacimiento in many ways, and a **heartfelt THANK-YOU goes out to everyone who answered our call for support and came to the hearing! You made a HUGE impact that day, and we are grateful you were there with us!**
