# Monterey County to release 1.5ft of water per week until June!

At the April 4, 2024 Resops meeting, it was announced that Monterey County intends to lower the lake level to below 787.5' elevation by June 1, to bring the water level below the top of the concrete spillway. This adjustment is for the safety of the workers who will be working in the spillway, replacing one of the concrete panels. This work was postponed from last year, and now the County has determined it has to start construction on June 1 of this year. The rationale behind this decision was the scheduled start date of the contracted company for the project, which the county was determined to meet.

Despite strong objections from the NRWMAC representative, repeated suggestions to verify with their contractor if a later date would be feasible, the county insisted on sticking to their original plan. The NRWMAC representative emphasized the adverse impact of losing 9 feet of water over 45 days on those dependent on floating docks and highlighted the wastage of water, especially considering the ample supply from the Salinas River due to other sources.

So, the 60cfs releases we had for a few weeks suddenly surged to 700cfs, then skyrocketed to over 1100cfs at the U.S.G.S. meter #11149400 on Monday, April 8, 2024. People who had set up their docks over the prior weekend are likely to encounter significant challenges upon their return. NRWMAC highlighted this as yet another instance of Monterey County's disregard for recreational considerations in their lake "management" practices. Moreover, NRWMAC expressed concern over the potential violation of the operating permit, which explicitly prohibits the wastage of water. NRWMAC is actively considering additional legal actions to compel Monterey County to halt these releases before further damage is inflicted upon the lake. Stay tuned for further updates on this matter.

#### NRWMAC vs MCWRA Lawsuit Update

Our lawsuit persists as both sides pursue discovery. Though this part of the litigation has been very costly, our attorneys have gleaned insights into Monterey County's (MC) likely defense regarding the 2018 water release. However, MC's requests often mirror information they possess, and are unable or unwilling to produce, seemingly aimed at draining our resources. We persist in requesting information from MC which supports our argument regarding recreation as one of the primary reasons for land condemnation that was used to create Lake Nacimiento.

While we remain optimistic about the strength and outcome of our case, additional financial resources are crucial. Despite our continued efforts over the past 25 years of interaction, Monterey County has shown no willingness to settle or engage in meaningful dialogue. We anticipate court-ordered mediation will be where our case's strength will become undeniable.
